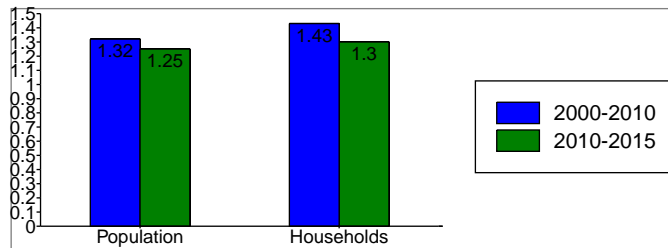

**Population and Households**

The size of the market area, measured by population and households, has changed from 2000 through the forecast year as follows:

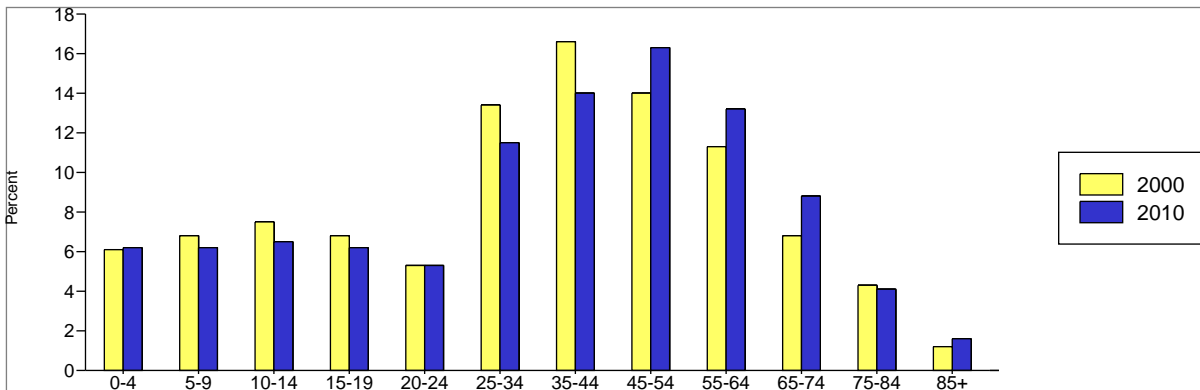

The difference between change in population and change in households is a result of two factors-the presence of group quarters (non-household) population in the market area and the average number of persons per household. The group quarters population in the market area was 114 in 2000, or 0.7 percent of the total population. Average household size is 2.53 in 2010, compared to 2.56 in the year 2000.



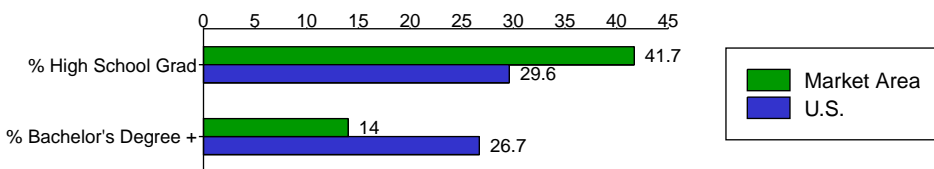
**Population by Age**

In 2010, the educational attainment of the population aged 25 years or older in the market area can be summarized:



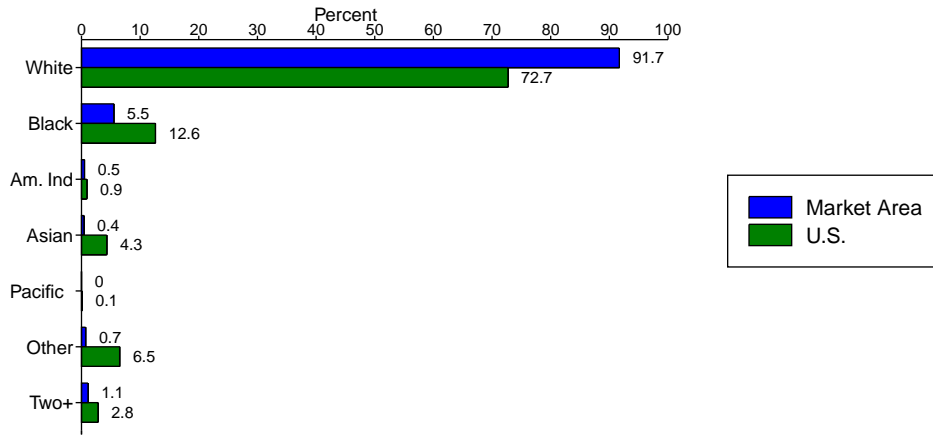

**Population by Race/Ethnicity**

Currently, the racial composition of the population in the market area breaks down as follows:

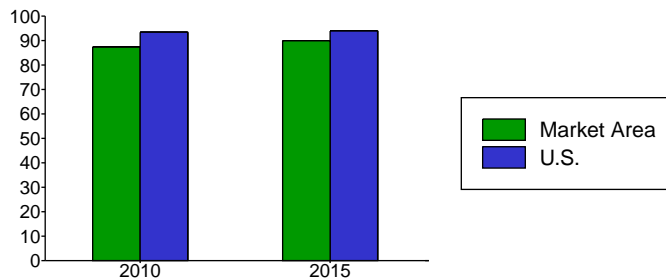


Persons of Hispanic origin represent 1.7 percent of the population in the identified market area compared to 15.0 percent of the U.S. population. Persons of Hispanic Origin may be of any race. In sum, the Diversity Index, which measures the probability that two people from the same area will be from different race/ethnic groups, was 18.4 in the identified market area, compared to 59.3 in the U.S. population.

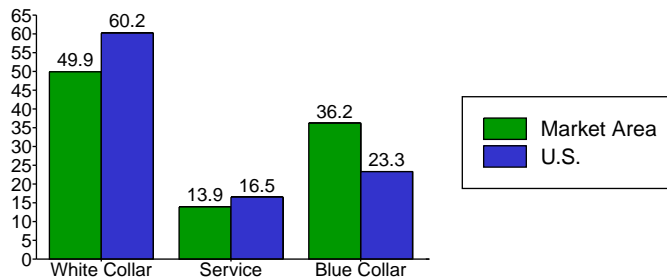
**Population by Employment**

In 2000, 62.7 percent of the population aged 16 years or older in the market area participated in the labor force; 0.0 percent were in the Armed Forces. Tracking the change in the labor force by unemployment status:

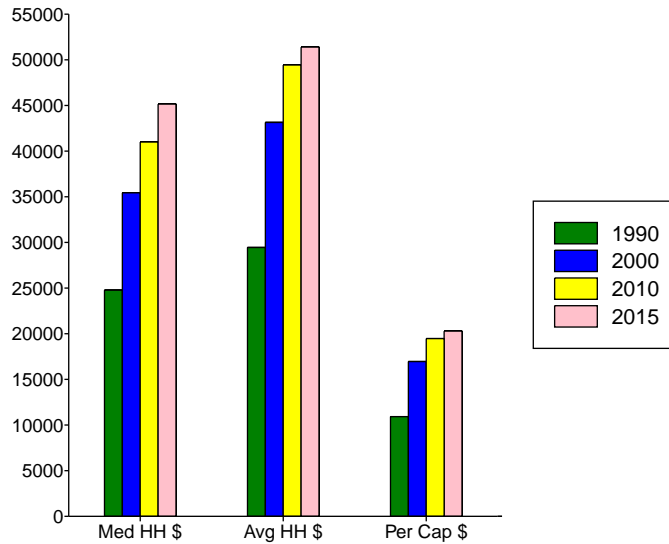

The change in three summary measures of income-median and average household income and per capita income-are shown below from 1990 through 2015:



**Housing**

Currently, 72.1 percent of the 8,046 housing units in the market area are owner occupied; 15.9 percent, renter occupied; and 12.1 percent are vacant. In 2000, there were 6,813 housing units- 74.2 percent owner occupied, 15.9 percent renter occupied and 9.9 percent vacant. The annual rate of change in housing units since 2000 is 1.64 percent. Median home value in the market area is \$105,323, compared to a median home value of \$157,913 for the U.S. In five years, median home value is projected to change by 3.26 percent annually to \$123,645. From 2000 to the current year, median home value changed by 3.32 percent annually.

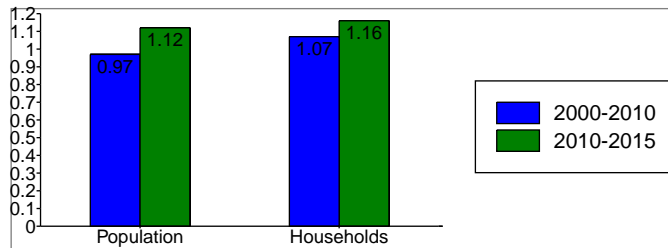

The size of the market area, measured by population and households, has changed from 2000 through the forecast year as follows:

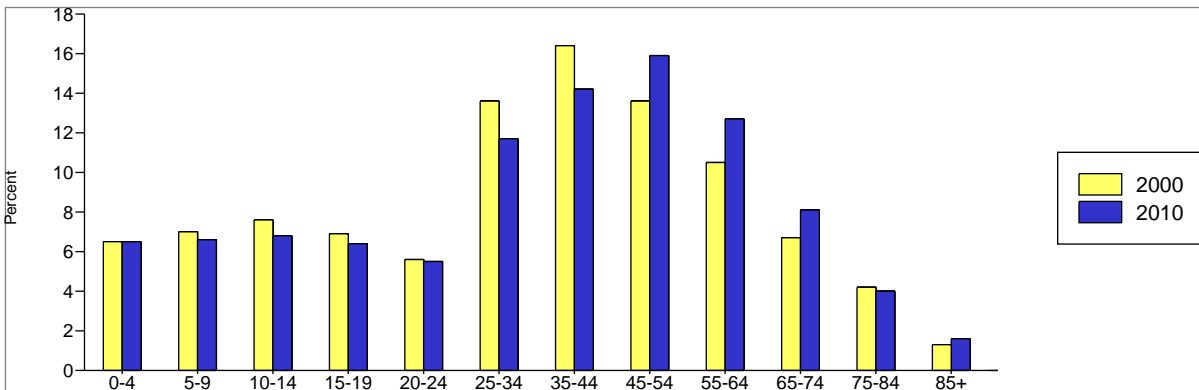

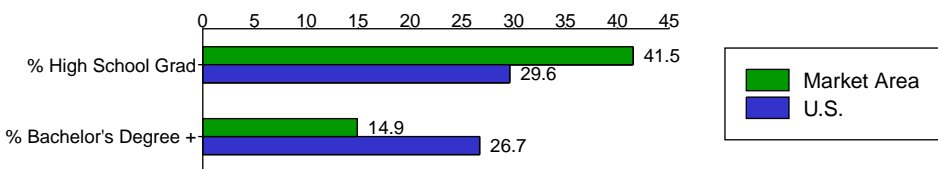
**Population by Age**

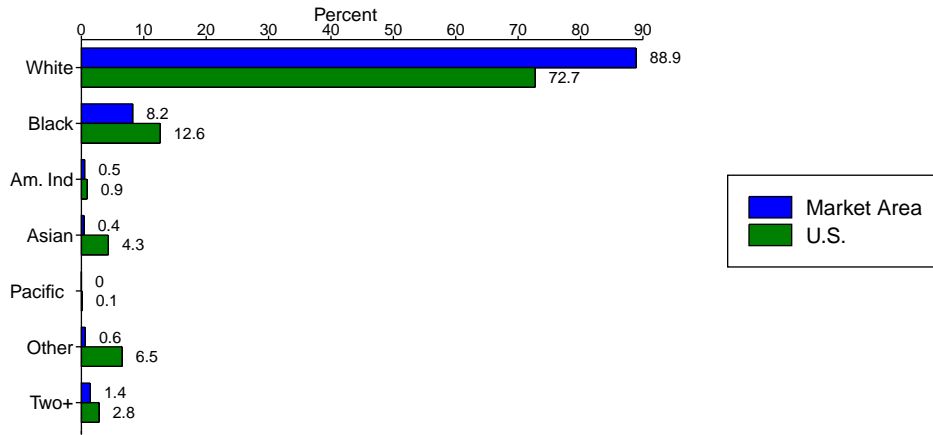

Currently, the racial composition of the population in the market area breaks down as follows:

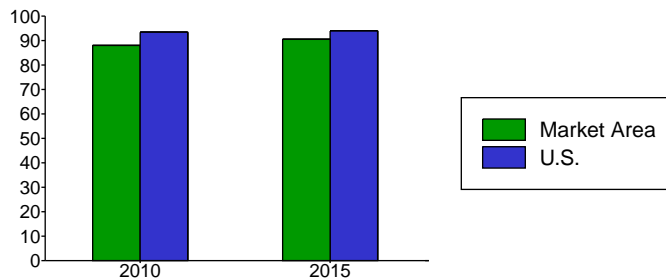

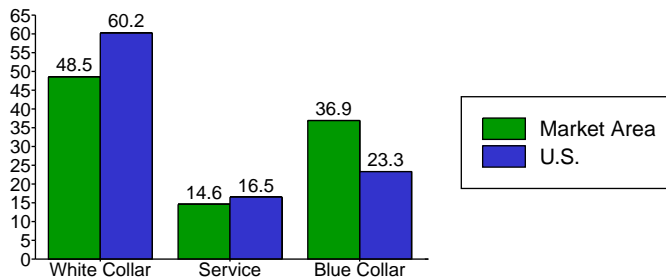
**Population by Employment**

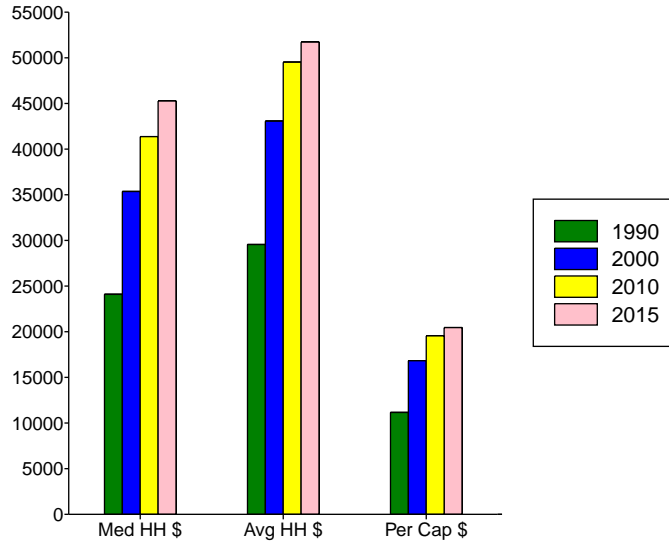

**Housing**

Currently, 70.4 percent of the 22,789 housing units in the market area are owner occupied; 17.6 percent, renter occupied; and 12.0 percent are vacant. In 2000, there were 19,908 housing units— 72.2 percent owner occupied, 18.1 percent renter occupied and 9.6 percent vacant. The annual rate of change in housing units since 2000 is 1.33 percent. Median home value in the market area is \$103,169, compared to a median home value of \$157,913 for the U.S. In five years, median home value is projected to change by 3.42 percent annually to \$122,078. From 2000 to the current year, median home value changed by 3.3 percent annually.
